Welcome to the Greenbelt Youth Center/Springhill Lake Recreation Center! These facilities are owned and operated by the City of Greenbelt, Department of Recreation and are supported by resident taxpayers and the City's general revenues. Please take a moment to review the rules that govern our facility before completing the form below. If you have any questions, our staff will be glad to assist you.

Rules and Regulations Governing Greenbelt Recreation Centers:

- Unacceptable behavior will not be tolerated. This includes, but is not limited to: the use of foul language; words or actions perceived as threatening; theft; misuse of equipment; disrespect of staff or other participants; and, fighting. Violators will be dealt with on an individual basis and are subject to penalties in accordance with department protocol.
- All participants, age eight (8) and above, who are utilizing the Youth Center, Springhill Lake Recreation Center or the Greenbelt Community Center gym as a drop in facility, must present a current recreation department facility ID each time they enter the building. Tangible proof of Greenbelt residency or a Greenbelt school ID is required to purchase a recreation ID at the resident rate. Facility IDs are non-transferable and non-refundable.
- Residents eighteen (18) years and older are eligible to purchase a weight room pass. The weight room is open to current pass-holders only. A daily entry fee option is not available.
- City sponsored programs have first priority for the use of the facility.
- **Children seven (7) years and younger must be accompanied and directly supervised by an adult, age eighteen (18) or above, recreation department facility ID holder while in the facility.**
- Participants must be appropriately attired (shoes, shirt, etc.) while in the facility.
- The City of Greenbelt is not responsible for participants' lost, stolen, or damaged items.
- Food and drinks are not permitted in the gym.
- Alcoholic beverages, illegal drugs and weapons are strictly prohibited. Persons suspected to be under the influence of alcohol or drugs will be refused admission to the facility and asked to leave the premises.

Facility ID cards and guest admissions may be revoked without refund for any violation of the rules. The revocation of privileges includes all recreation facilities operated by the City of Greenbelt, Department of Recreation. The City of Greenbelt reserves the right to review any other rule interpretation not covered in this document.

Protocol for Violation of Rules:

- Responsible behavior is expected of all participants. Unacceptable behavior in and around city recreation facilities and parks will not be tolerated.
- Violations of rules will be dealt with on an individual basis, with penalties ranging from the immediate ejection from the facility to the revocation of recreation department privileges.
- Any violation of the Center rules which imposes a potential threat or actual harm to other participants or staff will result in the immediate and indefinite revocation of privileges. Threatening actions include, but are not limited to: abusive language; declared threats; belligerent behavior; the possession of weapons; and, fighting.
- Unlawful behavior will also be subject to prosecution under the laws of the State of Maryland.

By signing, I understand, have read and agree to abide by the Rules and Regulations of the Greenbelt Recreation Centers and that during certain times of the day, areas of the facility may be closed for scheduled classes, events or rentals. **Membership cards must be presented at all times for facility admittance.** The City is not responsible for accidents due to improper usage of the facility. Falsification of this Membership Application may result in cancellation of the memberships and forfeiture of monies received. All memberships are non-refundable and non-transferable.
